Course organisation

- Classes are organised in 45-minute units (one school hour).
- The participant's placement in the appropriate group is based on his knowledge of language (placement test) when necessary.
- There are 8 to 15 participants in each group.
- The courses are elementary, intermediate and advanced.
- In unexpected circumstances the organizer reserves the right to temporarily join two groups or cancel the classes which will be carried out later or to organize e-learning on distance.
- If there are less than 8 students per group, the organizer can reduce the number of lessons.
